**Stage-1 Conditions:**

- a. Minimum **65%** marks in First Term Examination.
- b. Attendance upto First Term Examination **90%** and above.

If the above conditions are not met, 20% deduction in the approved scholarship amount will be made.

**However, in case of any disciplinary issue 100% scholarship amount may be cancelled.**

**Stage-2 Conditions:**

- a. **70%** in Second Term Examination results.
- b. Attendance upto Second Term examination **90%** and above.

If the above conditions are not met, 30% deduction or 30% additional deduction (where applicable in the approved scholarship amount will be done.

**However, in case of any disciplinary issue 100% scholarship amount may be cancelled.**

**Need Based Scholarship will be granted on Tution Fee only.**
